After serving in the U.S. Army for 12 years, Antonio had post-traumatic stress and anxiety. However, he successfully started his own construction business and was raising his two minor children. But with rental and other costs rising, he fell behind on payments to his landlord and the landlord filed for eviction. Antonio asked the Boston VA for help and his case manager connected him with VLS. Our team represented Antonio and helped him secure a veterans benefit to transition into new affordable housing. The landlord agreed to dismiss the eviction action and now Antonio and his children have a safe and stable place to live.
